### *Policies for Outside Users of the Wimberley Playhouse*

1. All users must adhere to the policies established in this document and to the terms of the Wimberley Playhouse Use Agreement Contract.

2. The Wimberley Playhouse meeting areas and performance theatre are available for use by individuals, small and medium size groups for civic, educational, performing arts and other cultural purposes.

3. Rental rates are discounted for non-profit groups. In addition, applications may be considered from non-profit groups unable to afford the discounted rates. If such applicant qualifies according to these Policies, facility use may be considered by special arrangement.

4. In addition to users renting the building, additional programming will be scheduled to meet the goal of the Wimberley Players Strategic Plan (Expanded Offerings section) to enrich the community with additional cultural offerings, as scheduling permits.

5. User must present documentation of proposed presentation

(may include outline, agenda, script, stills or video).

6. The facility is not intended for political or solely commercial events. No goods or services shall be sold or exchanged upon the premises, unless by agreement or direction of the Wimberley Players Board of Directors.

7. Solicitations for signatures or petitions are not allowed on Playhouse property.

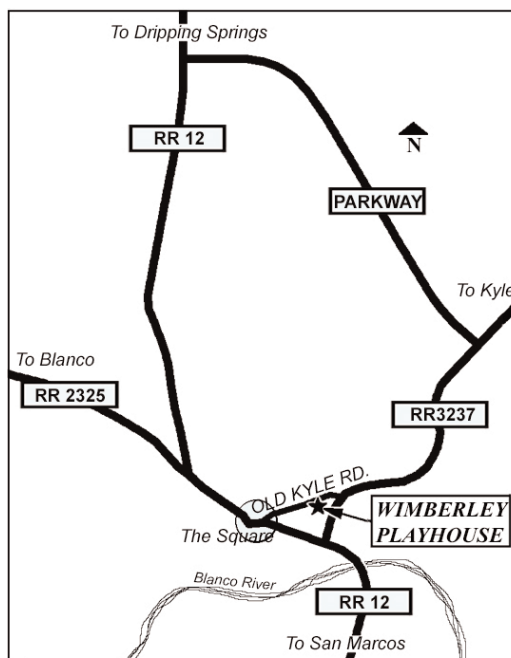
8. Requests for rentals of the Playhouse may be denied if the proposed event is

not considered in the best interest of the Wimberley Players, i.e., including such issues as potential saturation of the target market of the Wimberley Players, redundancy of programming, appropriateness or financial impact.

9. Use of the Playhouse for Wimberley Players purposes takes precedence over all other uses.

10. The Wimberley Players shall not deny use of the facility to anyone based on race, ethnicity, national origin, religion, creed, age or disability.

11. The Wimberley Players Board of Directors reserves the final authority to approve or deny an application for use of any part of the facility.
