Current Risk Level:	Response/Policies
Regardless of risk level:	 Covid vaccinations are required for all cast, crew and employees If any cast, crew or employee exhibits symptoms for Covid, they should notify the stage manager or their supervisor as soon as possible, and isolate from the theatre. Before returning to the theater, it must be 5 days since the onset of symptoms, and at least 24 hours of being fever free before the affected individual may return to the theater. If symptom free, but testing positive, the same criteria must be observed with the date of the test being Day 0
Testing:	 All members of the cast, crew, and creative team must provide proof of a negative COVID test no later than the Wednesday before tech, and no later than 12 PM (noon) before performance dates. If you are not eligible for testing through Curative at no out of pocket expense, advise the Managing Artistic Director at the earliest opportunity to make alternative arrangements.
LOW Less than 100 new cases reported (daily rolling average)	 During rehearsal period: Masks optional for Cast, Crew, Employees, and Volunteers During production run: Masks optional for Cast, Crew, Employees, Volunteers, and Patrons No signage required
Medium 101 - 250 new cases reported (daily rolling average)	 During rehearsal period: Masks optional for Cast, Crew, Employees, and Volunteers During production run: Masks optional for Cast, Crew, and Patrons; required for Employees and Volunteers Signage on the front doors stating that masking is optional but encouraged
High 251 - 500 new cases reported (daily rolling average)	 During rehearsal period: Masks requested for Cast, Crew, Employees, and Volunteers During production run: Masks requested for Cast, Crew, and Patrons; required for Employees and Volunteers Signage on the front doors stating that masking is requested
Very High 501 - 1,000 new cases reported (daily rolling average)	 During rehearsal period: Masks required for Cast, Crew, Employees, and Volunteers During production run: Masks required for Cast, Crew, Patrons, Employees, and Volunteers Signage on the front doors stating that masking is required
Extremely High Greater than 1,000 new cases reported (daily rolling average)	 During rehearsal period: Masks required for Cast, Crew, Employees and Patrons During production run: Masks required for Cast, Crew, Patrons, Employees, and Volunteers Signage on the front doors stating that masking is required The Players will follow state and local guidelines (whichever are the most restrictive) regarding social distancing and/or cancellations/rescheduling of performances
